The cooperation will enable the two libraries to exchange specialist personnel, publications, experience, and skills, and to share their information on their Chinese rare collections, while enhancing their future

■ The Establishment of TRCCS at the Kyoto University

On Dec. 20, 2016, NCL's collaboration with Kyoto University in Japan to establish a TRCCS on their campus attracted much attention from Japanese and foreign persons who attended the opening ceremony. Those in attendance included Chung-shi Kuo (郭仲熙), Deputy Representative of the Taipei Economic and Cultural Office in Japan, professors and library staff from the Kyoto University.

■ The Taiwan Lectures on Chinese Studies Are Hosted in Europe

On October 15, 2016 the NCL jointly hosted a Taiwan Lecture on Chinese Studies at Hungary's National Széchényi Library, a side event of the joint exhibition on "The Imprint of Civilization: The Amazing Journey of Boosk." Prof. Max K. W. Huang (黃克武), a distinguished research fellow of the Institute of Modern History at the Academia Sinica, delivered the lecture, entitled "Admired by Scholars and Laymen Alike: Introducing Some Classics in Chinese Society."
