specialized library with resources on the United Nations (UN), International Labour Organization (ILO), World Health Organization (WHO), World Trade Organization (WTO) and other major international organizations. The collection includes books, periodicals, CDs and microfiche resources.

An especially rare and historically significant part of the collection is the UN meeting minutes from 1947 to 1976, when the Republic of China (ROC) was a UN member. The collection also includes the meeting minutes for six major UN organizations, including the General Assembly and Security Council, from 1971 to the present. Costing over NT\$20 million, this exhaustive record is preserved on 111,271 rolls of microfiche, totaling over 6.65 million pages, presenting an invaluable resource for research. All of the collection resources can be accessed by the general public at the Center for Public Business Administration Education Library.

## Fourth International Conference of Institutes and Libraries for Chinese Overseas Studies

The Fourth International Conference of Institutes and Libraries for Chinese Overseas Studies was held at Jinan University in Guangzhou on May 8 to 10, 2009. Scholars and experts from related institutes and libraries delivered 200 papers for the three-day conference, which was held under the "Interaction and Innovation: theme of Multidimensional Perspectives in Chinese Overseas Studies." Over 210 people attended from 23 countries, including the United States, Canada, France, The Netherlands, Germany, the United Kingdom and Taiwan. Mr. Chen Tehan of the NCL presented an "Analysis of the Establishment of the Sino-International Library and Collection." The conference provided an interdisciplinary and multifunctional communication bridge for experts, scholars, librarians, and archive management personnel. (Chinese text by Chen Tehan)

### 2009 CNKI Forum on Digital Resource Integration and Services

The 2009 China National Knowledge Infrastructure (CNKI) Summit Forum was held on May 17 to 23 in Beijing. Representatives from Taiwan, Hong Kong, Macao and CNKI presented 13 papers at the forum. The NCL was represented at the event by Luo Chinmei and Lin Wenya. Subjects covered in the forum reports included: resource requirements and security for Chinese digital library development, digital resource integration platforms and service models, user experience sharing and institutional experience in digital library establishment. Each report was followed by a Q&A and discussion session. The organizers also arranged an institutional digital library for on-site demonstration and discussions. The forum concluded with a general discussion during which participants offered input on improving digital library services.

The organizers also arranged for visits to three different types of library, including the National Science Library at the Chinese Academy of Sciences, the National Library of China and Tsinghua University Library. The different operational modes of the three libraries presented ample learning opportunities for the visitors. The group was especially impressed by the subjectoriented librarian system and services at the National Science Library. Established in 2004, subjectoriented librarian services at the library include consultation services provided to users at the library, offices, and institutes. Consulting is also provided by phone, texting, e-mail, forms, and librarian blogs. The system was fully mature by 2009 and has achieved considerable results.
